

**INNIS ARDEN SWIMMING CLUB, INC.  
MEMBERSHIP POLICES**

**NUMBER OF MEMBERSHIPS:** The total number of memberships, including all categories of membership, shall not exceed 275. No more than 70 General Annual Use Permits shall be issued.

**WAITING LISTS:** Should interest exceed the number of available memberships, the Board shall keep a waiting list. Separate waiting lists shall be kept for the various membership categories, as needed. A written application must be made and a non-refundable fee in an amount to be determined by the Board must be paid in order to be placed on the waiting list.

**MEMBERSHIP CATEGORIES:**

**RESIDENT:** Open to Innis Arden property owners, with pool privileges extending to member's children and minor grandchildren. Initiation fee and annual dues apply.

**LIMITED USE PERMIT:** Limited Use Permits are intended for Innis Arden resident "empty nesters." Limited Use Permits are for tenured resident member adult or adult couple – no children or grandchildren privileges are afforded. Limited Use Permits are restricted in number and are limited to 50 swim sessions per season (no carry-over). Limited Use Permit applications are collected annually and permits awarded by March 31 solely on the basis of seniority of uninterrupted membership. Resident Members applying for but not awarded Limited Use may then fill out Resident Membership documentation by the pool opening date to continue as Resident Member. Annual dues apply – no initiation fee.

**ANNUAL USE PERMITS (GENERAL, LEGACY, FORMER RESIDENT):** The following Annual Use Permit categories are open to those living outside Innis Arden. These are year-to-year permits. The number of Annual Use Permits may be reviewed and adjusted on an annual basis by the Board. Priority will be given to those who held permits in the prior year. However, the Board is required to give membership priority to residents of Innis Arden.

**GENERAL ANNUAL USE PERMIT:** A non-Innis Arden resident membership affording pool privileges for a household in Shoreline west of Aurora Ave. N. or in the community of Woodway. The following geographic boundaries apply to Shoreline households: Southern boundary – N. 145th Street; East boundary – Aurora Ave. N.; West boundary – Puget Sound; North boundary – N. 205th Street. Two current Resident Member Letters of Sponsorship are required supporting the AUP application. The Board has sole discretion as to whether the permit will be granted. Initiation fee and annual dues apply.

**LEGACY:** An Annual Use Permit for an adult child of a current Resident

Member in good standing who resides outside Innis Arden. Legacy pool privileges are restricted to the household of membership and guests. Annual dues apply – no initiation fee.

**FORMER RESIDENT:** Affords a tenured active Resident Members in good standing moving out of Innis Arden the opportunity to transfer their membership to a Former Resident AUP. The former resident AUP affords pool privileges to a single household and their guests. Former Resident memberships are subject to Board approval, and application should be made prior to the termination of the Resident Membership. Annual dues apply – no initiation fee.

### **MEMBERSHIP RULES AND POLICIES:**

1. Resident Membership is available only to those who own a lot or lots as shown on the plats of Innis Arden, Innis Arden #2 and Innis Arden #3, which plats have been heretofore filed in the Auditors Office, King County, Washington.
2. Only Resident Members shall have voting rights.
3. Only one Resident Membership is allowed per Innis Arden property.
4. Members shall cease to be members upon the happening of any of the following events:
  - a) Upon the death of the member;
  - b) For membership categories requiring Innis Arden residency, upon the member ceasing to own a lot in one or more of said three subdivisions or upon the member ceasing to be a bona-fide resident of the area composed thereof;
  - c) Upon the failure of a member to pay when due, or within such grace period thereafter as may be established by the Board, any dues or assessment levied upon such member by the Board;
  - d) Upon the action of the Board determined by a unanimous vote of all the directors then serving, that the conduct of such member (or immediate family member under that resident number) is against the best interests of the Club, and the Board's decision in this regard shall be final and binding upon all persons and not reviewable by a court;
  - e) Upon the resignation of a member.
5. Memberships cannot be transferred. Memberships cannot be split between two or more households.
6. Resident members may allow a nanny or houseguest to use the pool. A written notice of this intent must be provided to and approved by the pool manager. A fee determined by the Board will apply and must be paid before pool privileges are extended.

7. The Board shall establish the due date and the amount of dues for the various categories of membership on an annual basis. No member shall use the swimming facilities of the Club unless and until the dues are paid.

8. Annual Use Permits. The owners of such permits shall be entitled to use the facilities and participate in the programs and activities of the club. Membership privileges are limited to the members of the household holding the permit – privileges do not extend to children and grandchildren who are not residents of the household. An application for an Annual Use Permit, in a form determined by the Board, shall be completed by each applicant. Applicants who are not former members of the club must be sponsored by two current Resident Members in good standing. The application fee must be submitted with the application, and after the application is approved by the Board the fee shall not be refunded. Annual Use Permits are not transferrable, and not to be sold or assigned. In addition to the termination events listed above, an Annual Use Permit shall terminate and all privileges there under shall cease upon the end of the calendar year in which the permit was issued. When permits are issued, priority will be given to those who held permits in the prior year. However, the Board is required to give membership priority to residents of Innis Arden. Should the number of Resident Members increase such that a reduction in the number of Annual Use Permits is required, the Board will issue the available Annual Use Permits based on length of uninterrupted years of holding a permit. Any permit holder who is not issued a permit for a particular year and who was issued a permit in the prior year shall be placed on the Waiting List ahead of persons on the Waiting List who did not hold a permit in the prior year.

9. One Year Hold. Memberships can be placed on a “one year hold” without forfeiting the membership. The hold fee is 50% of the annual dues fee for the year of the hold. While on hold status, a membership number is retained and the member is assured membership upon return the following season, so long as the member joins fully the following season – otherwise the membership would terminate. No swim privileges are allowed while membership is on hold. The Board, in its sole discretion, can limit the number of one year holds allowed in any particular season.

10. Code of Conduct. The following guidelines are designed to help ensure a safe and enjoyable swim club experience for all members. Anyone who acts in a manner not in accordance with these objectives will be subject to disciplinary action. All Members are expected to sign-in themselves and their guests at each visit to the swim club using the sign-in procedures set forth by the swim club Board and Management. It is expected that all members, including children and grandchildren, and all guests of members will conduct themselves in such a manner as to be respectful of other members. Inappropriate physical contact, harassment, bullying, inappropriate language (cursing or derogatory comments), theft, vandalism, maliciousness or misbehavior in the pool, locker rooms or surrounding areas, or any other illegal or inappropriate behavior will result in disciplinary action including, but not limited to, suspension or termination of membership privileges. Members participating in swim team activities shall also comply with the Greater Seattle Summer Swim League code of conduct.
